

Bus Policy

Student Code of Conduct:

Students utilizing the school bus service are expected to adhere to the following terms and regulations:

- 1. Be prepared and wait on time in a visible position for the bus driver before the bus stops.
- 2. Upon entering the bus, promptly take a seat, fasten seatbelts, and remain seated while the bus is in motion. Seat switching during travel is not allowed.
- 3. Always respect the instructions of the driver and bus assistant.
- 4. Keep aisles clear of books, bags, and other belongings.
- 5. Eating and/or drinking on the bus are strictly prohibited.
- 6. Maintain quiet conversations using an 'inside' voice.
- 7. Respect the property of the transport company.
- 8. Arrive on time at the bus stop in the morning and promptly board the bus at the end of the school day.
- 9. Show respect to the driver and assistant.
- 10. Do not open windows or dangle hands or head from the bus window.
- 11. Avoid actions and behaviors that may disturb the driver.
- 12. Refrain from tampering with or damaging any fixtures or fittings on the bus.
- 13. In the case of damaged bus property, the guardian will bear the costs of repairing the damage.

Parental Responsibilities for Efficient Bus Service:

To ensure an efficient and effective bus service, parents are strongly recommended to follow these guidelines:

- 1. Inform the bus monitor of any changes to their child's transport arrangements.
- 2. Provide updated telephone or mobile phone numbers to the school and relevant Bus Monitor for emergency contact.
- 3. Ensure that students are at the pickup point at the designated time to guarantee punctual arrival at school.
- 4. Ensure students leave the house on time, as the bus will not wait beyond 3 minutes.
- 5. Ensure a responsible adult is present to send and collect primary children to and from the school bus.
- 6. For any complaints or suggestions to enhance the bus service, contact the school administration.

- 1. The students must sit in their designated seat; changing seats during the trip is not allowed.
- 2. Eating or drinking on the bus is strictly prohibited.
- 3. Avoid using inappropriate language or comments towards the bus driver.
- 4. Keep hands and legs to oneself.
- 5. Always keep the bus clean.
- 6. Maintain a quiet demeanor.
- 7. The school reserves the right to terminate transportation service to any student not following regulations and instructions.
- 8. The guardian is responsible for the cost of damaged items caused by their student.
